### **SPECIAL MEETING**

### **MINUTES OF BUSINESS PUBLIC MEETING**

The meeting of the Community District Education Council of District 26 (CDEC26) was called to order by Robert Caloras, President at 7:10 pm in Room –B44A.

#### ***Business Meeting***

1. Review Budget Allocations
  - a. Council reviewed the budget allocations. Will make changes in allocations at the next meeting.
  - b. Erik spoke about having flyers printed and backpacked for the School Governance/Mayoral Forum meeting. Marie made a motion to accept the budget allocations as is & Erik seconded. Council voted unanimously to accept.
2. Bylaws -
  - a. Marie made a motion to accept the bylaws as is with no changes and Erik seconded. Council voted unanimously to accept.
3. Minutes – July, August & September
  - a. Marie made a motion to accept July, August and September minutes, Irene Fennel seconded. Council voted unanimously to accept.
4. CDEC Vacancy
  - a. Application distributed to council members to review. Applicant also applied for the City Council position. Council discussed setting up an interview with the applicant. Will get dates from the applicant and set up with council members.
5. Rescheduling School Governance/Mayoral Control forum date
  - a. Discussed having forum on Oct. 29<sup>th</sup> – members agreed unanimously.
  - b. Marian to send out “SAVE THE DATE” flyer to all.
  - c. Rob spoke about having flyers printed, delivering to all schools by council members and Marian plus backpacking by students. Requesting President Council to distribute and put on their calendar.
  - d. Invitations by e-mails (See attachment - A) Council members would like to know where the elected officials stand on this subject.
  - e. Post flyer on website
  - f. Vince spoke about advertising the forum with the courier, Chinese & Korean papers. Vince outlined the cost in the Courier (full page-\$800; ¼ page-\$300; ½ page-\$450). Irene Cheung will get rates from the Chinese & Korean papers.

Vince sent out a draft of what the ad would say to the members for their review (See attachment – B) and Rob would make the final decision. Marie made a motion to spend at least \$3500 for advertising for the October 29<sup>th</sup> meeting and Vince seconded. Council voted unanimously to accept. 8. Discuss Administrative Assistant salary increase. Rob have had conversations with others who stated that when the city union gets a raise, the Administrative Assts are suppose to get raises per Jackie Lipson.

Marie made a motion to adjourn meeting and Vince seconded. Council voted unanimously to adjourn.
