Business Meeting

Rob Caloras started off by introducing the 2008-09 CDEC officers: Rob Caloras, President; Jeannette Segal, 1st Vice President; Irene Fennell, 2nd Vice President; Marie Pollicino, Recording Secretary & Erik DePaula, Treasurer.

Rob informed the attendees that it has come to his attention that the business meetings be separated from the general public meeting and since D26 has been openings it's meetings to the public, it will remain the same. No issues have come up so it will remain the same.

2. President's Report

Senator Padavan donated \$54,000 to PS 94 for A/C's.

Anita will e-mail all principals to find out who received electrical upgrades. Once information is received from Anita, Rob will submit to the Community Board & SCA as a separate proposal.

Will ask principals if parent coordinators could print out the flyer & distribute to the students (backpacks).

Rob informed her of the School Governance/Mayoral forum date (October 23rd) but Senator Stavisky informed the council of other commitments of the elected officials and that would not be a good day so it was changed to Oct. 22nd.

Guest Speaker introduced by Rob:

Pete Maddaloni – Queens Borough Custodians Union

- a. \$18 million budget cut as of July lst.
- b. Union negotiated a budget cut of \$11 million
 - 1. incinerators (\$7,000 additional cut)
 - 2. spoke on kindergarten feeding cleaning before & after feeding (1/2 of the budget taken away)
 - 3. supplies cut back (hand towels soap)
 - 4. elementary & middle schools have lost full time personnel & they were made part time.
 - 4. cleaning & maintenance will not be performed as frequently. Allotment for supplies will be reduced also.
 - 5. work will be outsourced to other companies.

Matt Wilde, VP, Local 891 outlined the following:

- 1. Outlined further budget cuts: years, 96, 97, 2000 and now. Spoke about reallocation.
- 2. Spoke about custodians take pride in the exterior of their schools (planting of flowers & taking care of the grounds).

Ms. McGrath, MS 67spoke on the custodial cuts and states that she will support them.

Rob stated he will send a support letter.
