- II. Senator John Liu provided updates regarding the Education Committee.
- III. Alan Ong provided update regarding school opening and no remote option.

IV. Superintendent Report (Danielle Giunta)

- We are returning back to school September 13, 2021 and welcoming our students and families back. We are back 5 days in school. There are no remote option or hybrid unless if a classroom is quarantine.
- Superintendent shared documents and updates regarding guidelines from the Mayor. We are taking multilayer approach where health and safety is our priorities.
- Superintendent introduced newly appointed principal, assistant principals, and EA.
- Superintendent shared details about students testing positive in a classroom and quadrating for 10 days.
- We provided instruction for families who are interested in home instruction and home schooling.
- Alan Ong raised questions regarding 3ft mandates and capacity. Superintendent Giunta explained that we are splitting classrooms that are large and using spaces that we have not used in the past. We are using data capacity to ensure that we can maintain 3ft across all schools.
- All staff members are required to have vaccination by September 27.
- Superintendent shared information about random testing. We are only using the result of in-school testing.
- Breakthrough case- We still have the situation room, and they will map out the impact and will determine how many classrooms we will have. For middle school and HS, students are eligible to be vaccinated and in those cases, the scenarios may be different than elementary schools.
- Educational and Instructional priorities: We are working with principals how to intervene with students that may need extra help.
- All schools in District 26 are having a home welcoming activity. One of the new curriculums we are adding is civic for all curriculums. We will be going through a multi-tier support system to help students fill the gap.
- All students will be assessed through arcadian for ELA and for math, we will be using iReady. Our first set of assessment in District 26 will be September 27- October 22. We will be using the assessment to discuss with families about the growth of their child academically.
- We have some key dates to share, and schools have different start and end time because schools are holding professional development.
- Questions about I ready: I **Ready** is vetted through DOE and we have many of our schools are already trained I Ready, so we decided to continue to use it across the District.

- Question about differentiating between cold and covid- We will send the student to the nurse as usual. The Chancellor is hosting Town Hall in Queens focusing on health and safety.
- Question: Will indoor event be held in school and parent will be authorized to visit schools. We are still restricted, and we are waiting for further guidance.
- Question: Will attendance be considered in admission. We are still waiting for guidance regarding enrollment and what factors to be included in the admission process.
- Question: All of your principal received a survey that 1 to 1 device is available for all students.
