- Lucius Young presented on District Led Leadership Projects
 - Presidents elected at 5th and 8th Grade levels will be invited to a leadership training program.
 - A program for teachers who are aspiring to become APs will also be invited to participate in a school leadership training program.
- Quality Reviews will be conducted by the Office of School Quality but Supt. Giunta will be conducting the Principal Performance Observations, including community feedback.
- November is Parent Engagement Month there are a number of workshops and conferences being offered throughout District 26 and Queens North.

- O Lori Butera updated the committee on parent workshops past and present.
- This district is also attempting to integrate Student-Led Conferences (part of the Chancellor's Vision) at the Middle School. Parents are encouraged to bring their children to the Parent-Teacher Conferences.
 - O Lori Butera updated the committee on parent workshops past and present.
- Six principals have been selected to visit China in collaboration with the Chinese Bridge Delegation.
- The last position on the District 26 Leadership Team has been filled: Family Support Coordinator will be Kim D'Angelo.
