Aug 6 is the math test for summer school, August 7th ELA and August 8th is the makeup dates. Martin Van Buren has an interim acting VP who is very warm and welcoming. This is a very different atmosphere than students are used to. A suggestion was made that the principal and AP greet the students in the morning to establish a welcoming atmosphere. They will begin Pre-med program with a partnership with LIJ/North Shore Hospital and Polytech to partner for a Pre engineering program. They are hoping for some athletic programs utilizing the wonderful school grounds. They are considering a parent welcoming night with a student welcoming committee to encourage a sense of belonging and commitment to the school.

We have not received any official information of Blue Ribbon Schools but a preliminary notification that e PS 191 & PS 203 may receive official designation.

The NYS grades have been posted and showed an increase in ELA and in Math for D26. Science at 93% and in Social studies grade 11 at 96%. We have several outstanding schools who received very high scores with 97, 98, and 99. Middle schools still need additional work since scores are not as high.

Principals had a luncheon at the end of the year and Anita was asked to speak. She thanked them for being all their efforts and commitment to excellence and for being #1 in NYCDOE.

District 26 is still #1 in NYCDOE for the 2012 ELA and Math scores.. She explained that the progress report is very important because we want to show that the students are making progress. It's very hard for smart students because they need to be challenged. They must be accelerated.

She visited PS46 and was very impressed at the group work; the teachers have all the data and have placed the children in groups according to skills. There are only 16 days in summer school and the teachers are

trying to move the children who didn't pass in the spring to pass the test in August. Anita explained that teachers are getting support from other teachers to help students who don't get it. Teachers participate in team meetings during the year to improve their practice and feels we need more time for professional development. Next year with the Common Core learning Standards, the state reading and math tests will be more challenging. She explained how a sample question on a state test for 2013 will have questions based on every day experiences such as taking discounts at a store. In ELA, students will read complex texts and need to be able to surmise and explain. Some answers will not be directly stated in the text but need to be inferred. Finland is number one internationally and heavy emphasis placed is on providing extensive remediation. They also use very capable students to teach struggling students to understand how to reach those students.

At PS 74 students got 1<sup>st</sup> place in the spelling bee. They also got \$3000 for a recycling contest and PS 188 got \$1500 as well.

Another event at the PS 186 was the "Battle of the Teachers" where teachers compete and students cheer the teachers on. It promotes a wonderful atmosphere.

The state sent out a memo regarding a ban of ALL electronic devises during testing.

Anita will be on vacation from July 23 through August 3.

## Lori Butera (District Family Advocate)

Lori had two workshops and a parent orientation, thus far. Today, 25 parents attended the parent orientation stressing how to get involved. She expressed the need for more parents on the council. Another workshop will be Wednesday, July 18<sup>th</sup> showing the film, "Race to Nowhere." On Thursday, July 19, a workshop on "Building Resilience for Children" based on the book will be held for parents. The last workshop will be a "Meet and Greet" to welcome new PTA presidents on August 7 at 10 am.

Anita may provide the presidents with a sample grade 5 math question at a meeting during the year. She explained that some parents were under the impression that a Level 2 is a good mark.
