- 2. President's Report Jeannette Segal
- a. Jeannette stated to the council members that calls and e-mails have been sent to Hong Ken Tan since he has not been attending the meetings (missed three consecutive meetings). Reaching out to find out if he is resigning.
- b. Reiterated the Town Hall meeting of Feb. 15th-Chancellore stayed an extra 35 minutes with us and he was able to get some of the parents questions answered. Very successful and positive feedback received.
- c. Teacher's Evaluation letter drafted and read out will send to council members to have their input and once finalized, it will be sent out to everyone on the mailing list. .

Teacher Evaluation Report

As we approach the upcoming NY State ELA & Math test, the council would like to address the district on the research and information we received regarding the Teacher Evaluations that were recently publicized. The Department of Education under a court order released the 2007-08 through 2009-10 Teacher Data Reports for English and Math teachers in grades 4 through 8. The news media had file a Freedom of Information Law requesting for the documents and the courts ruled in the Medias favor. The reports and data compiled evaluated teachers on how much progress individual teachers helped students make in those two subjects and years. Teachers had been previously informed of their scores, parents and concerned New Yorkers flocked to newsstands to see the scores. This caused an array of questions from parents and educators.

It is important for a person to receive feedback on their performance; every job has some form of evaluation of a person work performance. The children should also be evaluated as a means to evaluate the progress the child has made, how else is a parent to receive feedback at the parent teacher conferences on how their child is progressing. Evaluation is not what is in question; the data is what has to be questioned. The score is based on 20% of the children's State ELA & Math scores the other areas of assessment carry a lower weight, that even if a teacher has high marks in those areas and children do not receive high score in the state test the teacher will be deemed inadequate (ineffective). This methodology enhances what we as parent have been fighting against high stakes testing and for schools not to teach to the test.

The accuracy of the report is being questioned as well since a few listings had the incorrect teachers and classes naming error were made, but how about when a teacher that has a gifted class with students scoring high 4's and her score is listed as inadequate. Or the valued teacher in a school who receives a single digit score when parents are attesting to the wonderful result the teacher has made in their child's progress. A formula or a single state test cannot fairly evaluate a teacher's performance.

The good thing about this evaluation is that it has been abandoned by the DOE; they have established this evaluation system as a failure. The new evaluation system is under study and being dubbed the "Teacher Effectiveness Project". We need an evaluation that is both fair to our students, teacher and community. Let's hope this does not cause the damage the previous evaluation system caused and hopefully we do not lose valuable teachers and families along the way.

- 1. Susan Shiroma- attended the Election process meeting with FACE in February.
- 2. Attended Helen Marshall's meeting regarding the Turnaround of High Schools in Queens (8 high schools).
- 3. Attended the CB8 meeting 3-21 asking for support for the Beacon programs. A CB 8 member informed her that if the Beacon closes it means no free summer school at that site. MS 158 will lose its Beacon programming as of July 2012. In attending Susan was given the official list which was provided by a Beacon program manager. MS 158 is in school district 26. Beacon programming is open to everyone in the community (not just the students at MS 158). This means a cutback on free afterschool services, free evening programming and free weekend programming.... leading to "Latchkey children, youth on the streets and old people with no place to go." (my quote used at CB 8 meeting this week).

As many of you know, the latest round of budget cuts proposes the elimination of 7 Beacons as of July 1, 2012 in regions of lowest need. DYCD has contacted the 7 Beacons slated for closure, and the list is below:
